### Meeting overview

The KCC received an update on the project, including the most recent factsheets:

The Agriculture Fact Sheet provides information on the co-existence of similar facilities and agricultural land both domestically and overseas.

ANSTO discussed how safety and security will be incorporated into both the design and operation of the facility and presented an initial concept design for the facility.

### Project update & New General Manager

Samantha Chard from the Department of Industry, Innovation and Science introduced herself to the committee as the new General Manager of the project.

She also discussed the AECOM site characterisation report which will be reviewed by the department to be released by end of July.

### ANSTO Safety & Security

Hefin Griffiths (ANSTO), Chief Nuclear Officer, gave an overview of the Safety and Security measures that would be in place at the facility. Mr. Griffith's presentation covered the following topics:

- Safety Fundamentals including the waste acceptance criteria & the safety case.
- Facility design for all scenarios including seismic events or flooding, multiple fail-safes on equipment and developed policies and procedures which are frequently reviewed.
- Radiation Monitoring inside and outside the facility.
- Licences required at the facility from the regulator.
